# About the Occupational Health and Safety (OHS) Resource Centre

The Occupational Health and Safety (OHS) Resource Centre is an online platform for all health care Joint Occupational Health and Safety Committees (JOHSC) and leaders. It provides easy access to agendas, minutes, resources, and actions to improve and enhance a culture of safety throughout British Columbia (B.C.).

This manual is for all health care workers accessing the OHS Resource Centre. All registered health care employees can access the OHS Resource Centre to see JOHSC meeting minutes in their organization and provincial OHS resources. JOHSC members, unions, and employer leaders can also manage meeting schedules, meeting minutes, resources, and reports from the committees they belong to.

The OHS Resource Centre was developed by SWITCH BC, with funding from the Nurses' Bargaining Association, the Facilities Bargaining Association, and the Ministry of Health. The OHS Resource Centre is supported by health unions (bargaining associations), health employers, and the Doctors of B.C.

### About SWITCH BC

SWITCH BC, which stands for Safety, Wellbeing, Innovation, Training and Collaboration in Healthcare, is an organization focused on the health, safety, and wellbeing of everyone working in health care in B.C. # 1. Introduction

### 1.1 Purpose

The 'KPIs and Reports' dashboard provides a collection of reports, metrics, and key performance indicators (KPIs) summarizing the effectiveness of JOHS committees in relation to regulatory compliance. The dashboard allows you to view key data, including:

- Committee composition and vacancies.
- The number and type of meetings scheduled in the next 30 days.
- The number of missed meetings.
- How often quorum is met/not met.
- A drill-through report on each participant's attendance status.
- The number of long-running agenda items.
- How many action items are open or overdue.

You can also use 'KPIs and Reports' to report on a specific range of employers operating and/or committees.

### 1.2 How to Use KPIs and Reports

Once you have logged in to the OHS Resource Centre as a practitioner, click on the dashboard tab to access the 'KPIs and Reports' home page. There you will see the tiles and charts displaying KPIs. The dashboard is organized into two tabs: 'JOHSC Composition' and 'JOHSC activities'. Here is the 'JOHSC Composition' view:



- Click on the tile (C) to view detailed data behind the statistics.
- Red statistics (D) indicate a KPI of concern.
